1. School Community Session- 5:00pm

- 1.1 Call to Order/ Pledge of Allegiance
- 1.2 Public Participation: Superintendent Arsenault thanked the Community Center for allowing the Board of Education to hold the meeting in the center to enable more public participation. Superintendent Arsenault said any questions that are being asked during public participation will be recorded, then reviewed by Arsenault, Walsh Park, and the board to assure that each person is receiving the most accurate information.

Fishers Island resident Bob Evans asked the board "Was the original appraisal done under current zoning or with the zoning Walsh park is trying to recieve? It seems to be since the deal is conditioned on getting the zoning, which enhances the value of the zoning, why is the school not getting that potential value?"

Fishers Island Resident Jane Ahrens asked "If the new zoning goes through, is the school district required to fulfill the maximum density allowed regardless of the zoning agreement?"

At the end of Public Participation, Fishers Island residents asked when there would be a public vote for this issue.

Superintendent Arsenault explained that there is not a referendum vote until there is a formal agreement with Walsh Park. Right now, there is a non-binding agreement with Walsh Park, which can potentially turn into a formal agreement pending the zoning approval. Superintendent Arsenault stated that if Walsh Park were to get the zoning approval, and move into formal agreement, then the BOE would schedule a referendum vote with the voters which would determine if the school was able to sell the land to Walsh Park.

The BOE received an anonymous letter on February 5,2020 from a concerned parent asking the board to look into the use of air fresheners at Fishers Island School. Superintendent Arsenault said after receiving the letter, he investigated at the school and disconnected any active air fresheners. Superintendent Arsenault also said he is looking into a potential no fragrance policy for FIS, and appreciates the concerned parent bringing this to the board's attention.

1.3 Celebrations:

A. Recruitment Open House: Superintendent Arsenault shared that FIS had their recruitment open house after putting a lot of time and energy into marketing resources, such as the video at the Mystic Movie Theatre. Superintendent Arsenault said he is very happy to report that the school had 10 students for the open house, trending on the younger side of Grade 5 and Grade 6 which is a positive for FIS. According to Superintendent Arsenault, the application deadline was the day previous to the meeting and there were 9 confirmed applicants so far.
